

USED VEHICLE INSPECTION / DELIVERY AGREEMENT

THIS AGREEMENT is made by and between Headstart Warranty Group (HWG), a Texas corporation, hereinafter "HWG", located at 14114 North Dallas Pkwy, Suite 600, Dallas, TX 75254, and the Dealer whose signature and address appear below, hereinafter, "Dealer".

The parties agree to the following facts, terms and conditions:

DEALER must perform inspections on every vehicle prior to being sold with an HWG service agreement. A copy of the vehicle's pre-delivery inspection checklist must be saved at the selling dealer. A copy of this inspection checklist may be requested on certain claims.

Dealer agrees to inspect used vehicles and to ensure that ALL PARTS AND COMPONENTS COVERED BY THE HWG VEHICLE SERVICE CONTRACT ARE FUNCTIONING PROPERLY AT THE TIME OF DELIVERY, AS EVIDENCED BY A VALID REPAIR ORDER. DEALER UNDERSTANDS THAT MECHANICAL FAILURES THAT SHOULD HAVE BEEN REPAIRED AS PART OF THE PRE-DELIVERY INSPECTION WILL BE DENIED AS PRE-EXISTING CONDITIONS.

FOR SERVICE DRIVE SALES, PRE-DELIVERY INSPECTION MUST TAKE PLACE NO MORE THAN 15 DAYS AND 500 MILES PRIOR TO THE VEHICLE SERVICE CONTRACT SALE DATE.

If the vehicle is within 1,500 miles of a major maintenance requirement (e.g., timing belt/chain replacement), as specified by the vehicle's manufacturer, the Dealer will either perform the maintenance or inform the customer, in writing, that it is the customer's responsibility to perform that maintenance in order to avoid a claim denial due to lack of required maintenance.

Dealer also agrees to perform the following procedures on every used vehicle before it is offered for sale with an **HWG** Vehicle Service Contract:

- a. Oil and filter change
- **b.** Cooling system inspection
- **c.** Brake inspection and performance test
- **d.** Air conditioning inspection and performance test
- e. Check fluid levels and condition (OIL, POWER STEERING, BRAKE, TRANSMISSION, ETC.)
- f. Check and repair any fluid leaks
- **g.** Check and repair electrical components (e.g., switches, motors, etc.)
- **h.** C.V. Boot(s), steering & suspension components inspection; replace as required.
- i. Repair or replace any parts or components found to be defective for which the **HWG**Vehicle Service Contract would provide coverage

This Used Vehicle Inspection/Delivery Agreement is made a part of and incorporated into the Dealer Agreement executed by Dealer and HWG, and Dealer agrees that all terms and conditions of the Dealer Agreement shall remain binding upon Dealer.
